### **QUARTERLY REPORT (Third Quarter) January – March 2014**

#### **Executive Summary**

The March quarter marked the beginning of a transformation for Red River Resources Limited (ASX:RVR) (“Red River” or “the Company”), with the exit of Iron Mountain Mining Ltd. (ASX:IRM) as a major shareholder, and the appointment of a new highly experienced Board.

- Iron Mountain Mining Ltd. (ASX:IRM) sold its equity share in Red River (49,914,512 shares) to various sophisticated and professional investor clients of corporate advisory firm Beer & Co.
- New highly experienced Board appointed to Red River.
- Subsequent to the end of the quarter, Red River has undertaken a strategic review and the outcome of this review was announced on the 29 April 2014. Regular updates will be provided to the market as implementation proceeds.

#### **Review of Operations**

Red River did not carry out any field work on the projects during the quarter.

#### **Corporate**

Mr David Zohar resigned as a Director of Red River on the 11 February 2014. Mr Suraj Sanghani was appointed as a Director of Red River on the 11 February 2014, and he was subsequently appointed Company Secretary on the 19 February 2014.

Iron Mountain Mining (ASX:IRM) announced the proposed sale of its equity stake in Red River on the 12 March 2014. This sale was completed on 31 March 2014, and the 49,914,512 shares in Red River held by Iron Mountain Mining Ltd. were sold to various sophisticated and professional investor clients of corporate advisory firm Beer & Co.

On completion of the sale, Mr Suraj Sanghani, Mr Noel Taylor and Dr Zhukov Pervan resigned as Directors of the Company.
